### **VENDOR GUIDELINES:**

All reservations are non-transferable. No refunds will be issued for cancellations.

#### **VENDOR SHALL:**

- A. Only use their designated area for limited purpose described on Exhibitor's Agreement. Vendor will not be permitted to sell, advertise, solicit, gather, promote outside of designated area.
- B. Provide their own tables, chairs and any other necessary items;
- C. Only sell items previously approved and listed in the Exhibitor's Agreement. The Greater Alliance Carnation Festival ("GACF"), may cause the removal of any item not listed in the Exhibitor's Agreement.
- D. Not interfere with the flow of traffic;
- E. Not smoke and/or permit smoking at vendor's booth; Alcohol and drugs are also prohibited.
- F. Maintain the booths in a professional, orderly and safe manner.
- G. Refrain from selling items with profane and/or offensive messages, salacious items, live animals, weapons, and/or illegal or counterfeit items (GACF has unilateral authority to determine which items conform with this paragraph);
- H. Safely secure all loose papers and materials and prevent the same from blowing away;
- I. Secure and/or remove any and all personal property located within the booth at the end of the day. The GACF and the City of Alliance shall not be responsible for any damage or loss to any personal property located within the Vendor's booth;
- J. Agree to abide by all rules and regulations established by the GACF and the City of Alliance Parks Department;
- K. Be responsible for all conduct and actions of Vendor's employees and/or agents. Vendor agrees to indemnify the GACF and hold it harmless from any and all claims, damages, costs and attorney fees in which may result from the Vendor's conduct of its operation during the event.
- L. Promptly remove their property from the parking lot at the end of the event.

Failure to comply with the terms and conditions of this agreement will be cause for immediate removal of the Vendor from the event. The Chairman, Craft and Vendor Show reserve the right to reject any applications for any reason. Pets are not permitted in the festival area. This is an outdoor craft show and will be held rain or shine. Vendors must be set up all 4 days.
